Yet, according to a 2011 survey conducted by the Association for Information and Image Management (AIIM), 40 percent of respondents said they have little to no confidence in the accuracy, accessibility and trustworthiness of their electronic information. Sixty percent said this is true about email, and 30 percent felt their accessibility of records across the organization was poor to very poor.
- Perceptive Software is one of only 14 enterprise content management (ECM) vendors to have its records management product certified by the Department of Defense. The DoD 5015.2 standard defines the basic requirements that are based on operational, legislative and legal needs that must be met by records management application products acquired by the DoD. The stringent testing is conducted by the Joint Interoperability Test Command, part of the Defense Information Systems Agency that tests information technology and national security systems.
